**ORDER GRANTING CORPORATE MONITOR'S  
MOTION FOR ENTRY OF ORDER FOR CORRECTED FIRST  
INTERIM DISTRIBUTION FOR CLAIMANTS OF OM GLOBAL LP**

THIS CAUSE, having come before the Court upon the Corporate Monitor's Motion for Entry of Order for Corrected First Interim Distribution for Claimants of OM Global LP (the "Motion"), and the Court, having reviewed the relevant pleadings and being otherwise advised in the premises, it is hereby:

**ORDERED and ADJUDGED** that the Motion is **GRANTED**. The Order dated March 12, 2014 is corrected, in part, for the Corporate Monitor to make a first interim distribution in the amount of \$60,875.80 (as opposed to \$200,000.00) in accordance with the procedures approved in the Order dated January 13, 2014, to the two claimants of OM Global LP with "allowed claims." In addition, the Corporate Monitor is authorized to transfer \$250,000.00 from the OM Global LP monitor account to the OM Global Investment Fund LLC monitor account. This Order shall not affect the Corporate Monitor's prior authorization to make a first interim distribution in the amount of \$2,250,000.00 in accordance with the procedures approved in the


Order dated January 13, 2014, to claimants of OM Global Investment Fund LLC with “allowed claims,” and to claimants who properly and timely cure any claim deficiencies.
